## Two LWVOA Members to receive '8 over 80' Honors

**Jewish Senior Life of Metropolitan Detroit annually recognizes eight individuals over 80 years of age who have dedicated their time, talents and lives to the community and are still doing so.** This year 5 women and 3 men have been selected for the Tikun Olam Award for their contributions to 'repairing the world'. Among the honorees are two long-time members of the League of Women Voters: Frances Fisher and Judith Levin Cantor.

**Fran Fisher** has served as Co-President, Treasurer, Vice-President of Voter Service and as a Director of LWV Oakland Area and its predecessor Leagues. Voter guides, candidate forums, voter registration, explaining proposals to groups, issue studies on topics ranging from education to natural resources – she has participated in them all. Fran has been a role model and an active volunteer. She taught science at Hillel Day School for 30 years to 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> grade students, creating her own curriculum and offering innovative fun activities (including some on her own time) which taught them about plants and animals and the environment before it was fashionable. When students meet her years later, they hug her and tell her how she interested them in careers in science or medicine.

Fran served as President of the Orchid Society and is known as a plant doctor who can revive others' sick plants. She was involved in the Brandeis book sale and served as President and later mentored younger women who formed its Book Stock successor to raise funds for various causes. She trained as an AARP Tax Aide and offers free help for people in completing their tax forms. Alumnae of her college sorority still meet for lunch regularly because she initiated the lunches and is involved in their continuation to maintain those friendships.

**Judith Levin Cantor** joined and was active in the League of Women Voters in the mid-50's. She has been a history teacher, an archivist, an author, an editor, a curator, a speaker and a volunteer in a variety of community organizations. Her writings include "Jews in Michigan: Discovering the Peoples of Michigan" which received an outstanding book award from the Michigan Historical Society. Judy has curated exhibits on "Blacks and Jews: The Michigan Perspective" at Wayne State University, "The Sinai Heritage" now at Huron Valley Sinai Hospital, "Becoming American Women in Michigan: The Jewish Immigrant Experience" at the Detroit Historical Museum and Michigan Hall of Fame, and "Haven to Home in Michigan" celebrating 350 years of Jews in America at the Detroit Historical Museum in 2009 and now at the Holocaust Memorial Center.

She is a Past-President of the Jewish Historical Society and served on the Board of Directors of the Michigan Women's Historical Center and Hall of Fame and as a Trustee of the Historical Society of Michigan. She has received numerous awards including the 'First Lady of Michigan' Award in 1987 during the Michigan Sesquicentennial, the Leonard Simons History Award from the Jewish Historical Society of Michigan in 1998, and the Medal of Honor from the American Jewish Historical Society in 2009. She was a charter member of the Friends of the Bloomfield Township Public Library.

The **Eight Over Eighty** honorees will be inducted into the Senior Adult Jewish Hall of Fame at a community **Brunch** held on **Sunday, May 16<sup>th</sup> at 11 am** at the Jewish Community Center in West Bloomfield. Contact our office for more details if interested in attending. Fran Fisher and Judy Cantor are two truly exceptional senior adults who still continue to contribute to the community!

The Oakland Area LWV was pleased to have two speakers give excellent presentations at our February meeting concerning the conditions in Michigan prisons, particularly for women prisoners.

**Barbara Levine, Director of CAPPS (Citizens Alliance on Prisons and Public Spending)** spoke first and opened by noting that prison size is not driven by crime rates, but by policy decisions, especially regarding parole. For example: during the 1980s and '90s there was a Get Tough mentality. There were 36,000 prisoners in the early 1990's – that went up to 51,000. Various issues affected the fluctuation.

- For example, the "Good Time" policy was eliminated. It was a progressive system that meant if a prisoner served time without new penalties she could have time reduced from her sentence.
- During the 1990s there was a federal program called Truth in Sentencing that required violent offenders to have to serve 75% of the time of their sentence, but it was stiffened here even though it already was happening in Michigan,.
- There is a pending bill now to restore the "Good Time" policy but there is no chance of its passing in the Michigan Legislature.
- Michigan is currently out of sync with the other states and the Federal Government in its parole policies.
- Currently it costs \$34,000 a year to house the average prisoner.
- Twenty years ago the Corrections budget was 5% of the state budget; today it is 23%.

Our second speaker was **Monica Jahner, who has been an inmate in Michigan prisons**. She served a lengthy prison term for "conspiracy to commit murder" where there was no death. During her time in Michigan prisons, Monica served as a "Jail House Lawyer" -- helping other inmates. She has taken part in the "Arrow" Advocacy Program that helps with housing and jobs after release. She commented that the Department of Corrections (DOC) breeds dependency on what to do and how and when to do it, whereas those released need to learn to be independent. We are not protecting society by warehousing people in prison with training and programs reduced:

- If the GED programs were returned to Michigan prisons, then those taking the GED program could be encouraged to help other inmates with their education. GED programs help self esteem.
- There are no longer the prisoner newspapers or prison libraries that existed until the mid-90's.
- Juveniles continue to be incarcerated in adult facilities in Michigan. They should be housed separately.
- There are more mentally ill in the state prisons than there used to be due to the closing of separate facilities for those with such problems. They are medicated/sedated to keep them "calm".
- Overcrowding and variable visitation policies make it rougher for inmates.

Although Monica is, herself, on parole she has permission to work with other women who are on parole. She now works with the DOC by helping women prisoners who are being released deal with the reality of getting back into society. For example, many are homeless and need help with housing. She noted:

- We don't hear as much about prisoners who are released, get an MA and then enter into a social work career. We usually hear of just the problem cases.
- The term, "on parole" means supervision for 2 years by a parole officer regardless of the length of sentence. However, you cannot keep someone in prison or on parole past the maximum time of the sentence.
- Some parolees qualify to be on a tether which allows them to be in society under certain conditions. Parole officers watch the GPS monitor to know what the parolee is doing.

We, LWV members, were given suggestions of what we might do to help the situation with Michigan prisons.

- Help return the GED program for prisoners.
- Lobby for the restoration of Pell Grants for use by prisoners.
- Work for "banning the box" in Michigan. This refers to a box on an employment application that asks if you have been a felon. Checking the box creates an oppressive stigma for the individual who is working to turn their life around.
- Work to allow removal of the "sex offender" identification for some. Some states have gradations to their sex offender registry. Michigan has no such gradation. It is possible to be on the registry without being in prison.

Each person attending the program was given the Winter 2010 copy of the CAPPS publication *CONSENSUS*. One article was titled: **CAPPS 10-point plan** gains traction. The article describes the CAPPS plan **to reduce Corrections spending in 2010**. Its recommendations are grouped as follows:

1. Prison sentences should be reserved for people who are dangerous.  
Sentencing reforms and alternative sentencing options are needed.
2. The people who are sent to prison should be prepared as effectively as possible for their return to the community.  
These include in-prison programs, family support, good-time credits, and community re-entry programs.
3. The parole decision-making process should maximize the release of people who do not present a current threat to public safety. Use the minimum sentence unless objective factors demonstrate prisoner is a current threat.

## League of Women Voters receives Proclamation to honor its 90<sup>th</sup> Anniversary
