- At the clerk's office in the community in which you live,
- Or at any Secretary of State driver's license office,
- Or at offices of Family Independence Agency, Dept. of Community Health, and Michigan Job Commission,
- Or at military recruitment centers.
- Also mail-in registration form (with in-person vote 1st time)

YOU MAY VOTE IF YOU ARE:

- a citizen of the United States, and
- 18 years of age by the date of election, and
- a resident of the community for 30 days, and
- registered to vote 30 days or more prior to the election; unless you move, you do not need to re-register.
